***Early Bird Payment and cut-off**

Course Pre-Requisites:

It is a **requirement** of the Clinical Hypnotherapy Training **that all students be of good character** and have **no serious previous criminal convictions**. This is because all hypnotherapy associations of good standing in Australia require a formal Police Clearance or a Working with Children Card. Further to this as a practising therapist you will generally require insurance which again may require a good character check.

Clinical Hypnotherapy Training does not require you to produce a police check.

Competence in written and spoken English are required (not formal), **as is psychological stability** – speak to your trainer (or psychologist) for any questions.

Code of Ethics

Clinical Hypnotherapy Training has adopted as its minimum standard Code of Conduct for students and graduates the Hypnotherapy Council of Australia MINIMUM STANDARD OF ETHICAL PRACTICE/CODE OF CONDUCT. This is based upon The NSW Code of Conduct (2012) for unregistered health practitioners.

No Recording or photography allowed during the training

Clinical Hypnotherapy Training and its representatives **do not permit** devices to be on during any training sessions. Switched off means switched off. We have three breaks during the day during which you can check phone messages and answer calls. Whilst you are on the course If you have children at school please arrange for another responsible person to be nominated as secondary contact.

Refund Policy

The refund policy for all hypnosis trainings is as follows. After acceptance into the academy training and payment of fees there is no cooling off period and there are absolutely no refunds, although once registered a student can defer their training to any equal training within three (3) years of payment. (See Deferment Policy)

If removed from the training due to breach of terms and conditions any refund will be at the discretion of Clinical Hypnotherapy Training after any and all costs are taken into consideration.

Cancellation Policy

In the rare event that Clinical Hypnotherapy Training cancels any training in its entirety a full refund will be issued within 21 days of any such cancellation. The academy will NOT BE RESPONSIBLE and WILL NOT refund any travel or accommodation payments.

Students who may be travelling to attend any trainings it is recommended that you book your airfares and/ or accommodation on a changeable or refundable basis. These conditions are absolute.


Deferment of Training Policy
